NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **John Robert Armstrong** and **Catherine Anne Armstrong** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 19 (2) paragraph (a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL70 Burgh Marsh.

A summary of the effect of the application is as follows: Burgh Marsh was provisionally registered as common land on 23rd May 1968 under section 4 of the Commons Registration Act 1965, pursuant to an application made by Burgh Marsh Proprietors dated 2nd May 1968 and numbered 420 ("the 1968 Application"). The provisional registration of the 1968 Application became final on 17th August 1982. The Applicants claim that the land edged red on the attached plan ("the Application Land") was not included in the plan attached to the 1968 Application and the registration authority made a mistake in including the Application Land within the boundary of CL70 Burgh Marsh. The Applicant seeks by this application to remove the Application Land from register unit CL70 Burgh Marsh.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register CL70 confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in unit number CL70 as registered common land and the Application Land marked as deregistered.

Any person wishing to make representations:

- must quote the Application No. **CA10/10**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 21st April 2016
