

## Commons Act 2006 - Section 8 NOTICE OF APPLICATION FOR APPORTIONMENT OF RIGHTS OF COMMON

Notice is hereby given that an application has been made by **George Hutton, Margaret Hutton, Thomas James Hutton and Philip Brownrigg Hutton** ("The Applicants") to Cumbria County Council as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 10 of the common land register unit CL293 Mungrisedale Common

A summary of the effect of the application is as follows: The following right is attached to Eyecott Farm, Berrier comprising O.S. field numbers 222, 220, 219, 230, 235, 232, 233, 150pt, 228, 124, 136, 135, 128, 127, 129, 130, 131, 134, 138, 122, 101, 142, 141, 143, 141pt, 242, 69, 66, 27, 28, 68, 140, 139 and are exercisable over the whole of the land in register unit CL293 Mungrisedale Common.

"The right to graze 525 ewes and followers and 250 hogs" ("The Right").

Pursuant to the division of the land to which the Right is attached, the Applicants seek by their application to register apportionment of the Right appropriate to the parts of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 10 will be deleted and the reference made to the new corresponding entries.
2. Addition of a supplemental map.
3. The following entries will be made to the rights section of the commons register to show the proportionate apportionment of the Right to the applicant (a) and the remainder of the rights (b):

a. The right to graze 19.4 ewes and followers and 9.2 hogs, on Mungrisedale Common, comprising the whole of the land in this register unit. The right is attached to O.S. field number 134pt coloured pink on the proposed supplemental map.

b. The right to graze 505.6 ewes and followers and 240.8 hogs, on Mungrisedale Common, comprising the whole of the land in this register unit. The right is attached to Eyecott Farm – 222, 220, 219, 230, 235, 232, 233, 150 part, 228, 124, 136, 135, 128, 127, 129, 130, 131, 134pt, 138, 122, 101, 142, 141, 143, 141pt, 242, 69, 66, 27, 28, 68, 140, 139 shown coloured blue on the proposed supplemental map.

Any person wishing to make representations:

- must quote the Application No. **CA3/7**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must state the grounds on which they are made and must be signed by the person making them;

Any representations made will not be treated as confidential, to determine the application it will be necessary for the authority to disclose information received from you to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5 pm on 9<sup>th</sup> September 2016.
