NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Julius Piers Manduell, Matthewman David Manduell, Sir John Manduell** and **Lady Renna Manduell** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Section 19 (2) paragraph (a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to village green register unit VG104 School Green, Netherwasdale.

A summary of the effect of the application is as follows: School Green, Netherwasdale was provisionally registered as a Village Green on 12th June 1970 under section 4 of the Commons Registration Act 1965, pursuant to an application made by Netherwasdale Parish Meeting dated 17th October 1969 and numbered 1632 ("the 1969 Application"). The provisional registration of the 1969 Application became final on 17th August 1982. The Applicants claim that the land edged red on the attached plan ("the Application Land") was not included in the plan attached to the 1969 Application and the registration authority made a mistake in including the Application Land within the boundary of VG104 School Green, Netherwasdale. The Applicant seeks by this application to remove the Application Land from register unit VG104 School Green, Netherwasdale.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register VG104 confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in unit number VG104 as registered village green and the Application Land marked as deregistered.

Any person wishing to make representations:

- must quote the Application No. **CA10/26**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and


Representations will not be treated as confidential, to determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
