Where in situ preservation is not possible or justified, the development will be required to make adequate provision for excavation and recording before or during development. Any heritage asset and its setting, whether designated or not, that is harmed by a proposal, will need to be recorded by the developer to a level that is proportionate to its significance and to the scale of impact of the proposal. The information will need to be made publically accessible in the County's Historic Environment Record.
