## The Commons Act 2006 - Schedule 3 para 2(b) Application to amend the register to record an historic event

Notice is hereby given that an application has been made by **John William Young, Susan Mary Wearing, Kathleen Miller** and **Carol Elizabeth Muir** ("the Applicants") to Cumbria County Council as Commons Registration Authority under Schedule 3 paragraph 2(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL67 Matterdale Common.

A summary of the effect of the application is as follows: The right to graze 26 stints (one stint being equal to six barren ewes or four ewes with lambs or one head of cattle, or one horse equalling two stints) on Matterdale Common comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross at Entry 57 of register unit CL67 in the names of John Chapplow Young, John William Young, Susan Mark Irving and Kathleen Miller. By a Deed of Gift dated 27 August 2002 the Right was transferred to **John William Young, Susan Mary Wearing, Kathleen Miller** and **Carol Elizabeth Muir**. The Conveyance does not operate at law to transfer the ownership of the Right until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in their own names.

If the application is granted, the registration authority will give effect to the determination by deleting current entries (making reference to the new corresponding entries) and making new entries in the register to show the Applicants as owners of the Right.

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
