The Commons Act 2006 - Schedule 3 para 2(b) Application to amend the register to record an historic event

Notice is hereby given that an application has been made by **David Bowe** and **Norman Bowe** ("the Applicants") to Cumbria County Council as Commons Registration Authority under Schedule 3 paragraph 2(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL26 Skinburness and Calvo Marsh.

A summary of the effect of the application is as follows: The right to graze 4 stints (one stint being equal to one beast or four sheep or two sheep and four lambs) on Skinburness and Calvo Marshes comprising the whole of the land in this register unit ("the Right") is currently registered as held in gross at Entry 50 of register unit CL26 in the names of the Trustees of Joseph Bewley deceased per Mr F.B Moffatt, 15 King Street, Wigton. The Applicants claim that the Right was transferred to them by way of Conveyances dated 26th May 1982. The Conveyances do not operate at law to transfer the ownership of the Right until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in their own names.

If the application is granted, the registration authority will give effect to the determination by deleting the current entry (making reference to the new corresponding entry) and making a new entry in the register to show the Applicants as owners of the Right.

- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 9th November 2016
