Course Title	Domestic and Sexual Violence Level 3 Advanced
Background	This course is specifically for professionals who have an on-going role working with someone who has been sexually assaulted or is a victim or survivor of domestic abuse. This includes many frontline roles but not those who work in specialist domestic or sexual abuse support roles
Course Aims and Objectives	<p>Refresh professionals' understanding of Domestic Abuse and Violence, Sexual Assault and Abuse, including updating their knowledge of current legislation and prevalence, and the interrelationship between the two forms of abuse.</p> <p>Understand professionals' responsibilities in relation to these forms of abuse and assault.</p> <p>Understand myths and preconceptions about these types of abuse and assault and how that can provide a barrier to people coming forward for help, or to professionals working effectively to prevent further harm. Gain confidence in responding to and challenging myths.</p> <p>Develop an understanding of the less obvious signs and symptoms of these types of abuse and assault so that they can help to ensure they do not get missed.</p> <p>Develop an understanding of the impact of sexual and domestic abuse and assault on adults, both short and longer-term.</p> <p>Develop an understanding of the impact of sexual abuse/assault on children and young people, both short and longer-term.</p> <p>Consider your own response to those who may disclose.</p> <p>Gain confidence in dealing with disclosure.</p> <p>Understand the importance of effective risk assessment and how to do it, learning from serious case reviews.</p> <p>Understand effective Information Sharing processes in this context.</p> <p>Understand specialist support services available, their benefits for your service user and referral pathway.</p>

	<p>Develop an understanding and gain confidence in supporting a service user who has experienced domestic abuse or sexual assault/ abuse in an appropriate way, alongside specialist services. This includes confidence in discussing domestic abuse and sexual assault with a service user and understanding the level of involvement which is appropriate and not appropriate for your role.</p>
