**NOTICE OF APPLICATION FOR REGISTRATION TO TRANSFER A RIGHT OF COMMON IN GROSS**

Notice is hereby given that an application has been made by **Michael Henry Richard Cutler** (“the Applicant”) as **Executor for Erica Fay Holgate, Deceased** to Cumbria County Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL26 Skinburness and Calvo Marshes.

A summary of the effect of the application is as follows: The right to graze 7 stints (one stint equals one beast or 4 sheep or 2 sheep and 4 lambs (“the Right”) on Skinburness and Calvo Marshes comprising the whole of the land in this register unit are currently registered as held in gross (not attached to land) at Entry 222 of register unit CL26 in the name of **Erica Fay Holgate**. The Applicant claims that **Jeanette Sinkinson** (“the Transferee”) has acquired ownership of the Rights upon the death of the late Erica Fay Holgate under the terms of her Will and an Assent dated 19<sup>th</sup> August 2016. A transfer of ownership of a right held in gross does not operate at law until registered by the Commons Registration Authority in the commons register. The Applicant seeks by this application to complete the transfer of ownership and register the Right in the Transferee’s own name.

If the application is granted, the registration authority will give effect to the determination by amending the commons register to show the Transferee as the owner of the above mentioned Right.

Any person wishing to make representations:


- must quote the Application No. **CA6/25**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and
- must be sent to: The Commons Registration Service, Lady Gillford’s House, Petteril Bank Road, Carlisle, Cumbria, CA1 3AJ

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 11 November 2016.

Documents relating to the application are not available online; these are only available for inspection at The Commons Registration Service at the above address, strictly by appointment only. Please contact the Commons Registration Team on (01228) 221026 to arrange an appointment.
