The ninth and final triennial review of serious case reviews (Learning for the future) was published by DfE in December 2022. It was led by a team from University of East Anglia, who commissioned Research in Practice to produce resources to support learning for professionals and organisations across the safeguarding partnership. These resources are available on the open access website here and include briefings for social work, health, police and education.

This workshop delivered by Dr Julie Wilkinson, will present the key messages from the Review and will include:

- An overview of key data
 - Themes and trends across Reviews between 1998 and 2019
 - Key themes for practice, focused around neglect and poverty; information exchange and effective communication; noticing and responding to children's behaviour

Trauma Informed Practice Training

A trauma informed approach to safeguarding children in a multi - agency context.

Aims:

This one - day training event is for anyone professionally responsible for safeguarding children. This event will consist of a one day interactive in person, training event and a follow up two - hour supervision session. There will be two opportunities for people to attend this course.



The aim is to provide access to some of the key trauma informed concepts, tools and techniques professionals in Health and Social care, education and the justice

system can use in their day to day work, when working with vulnerable children and their families and carers.

Objectives:

Participants will be introduced to a trauma informed approach informed by the work of Dr Bruce Perry, the Anna Freud Centre and Therapeutic Life story work international.

Learning outcomes:

Participants to understand how trauma impacts on child development and how to respond in a trauma informed way so to better engage vulnerable children and their families when working together to safeguard children.

Domestic Homicide Timeline Training

This webinar will present an overview of the Homicide Timeline and the Suicide Timeline and the interactions between perpetrators of coercive control and intimate partner stalking and their victims, including how these interactions may be linked to escalating and de-escalating risk of serious harm or suicide.

The webinar will take place Monday 20th March 2023, commencing at 9.30am, finishing at 2.10pm.



The trainer, Jane Monckton-Smith is a Professor of Public Protection at the University of Gloucestershire with a specialism in homicide, coercive control and stalking. In addition to her academic work, she maintains a diverse portfolio of professional work and case work.

Jane works with families bereaved through homicide helping them with criminal justice and other processes; she advises homicide review panels, as well as chairing statutory Domestic Homicide Reviews. This webinar will present an overview of the Homicide Timeline and the Suicide Timeline and the interactions between perpetrators of coercive control and intimate partner stalking and their victims, and how these interactions may be linked to escalating and de-escalating risk of serious harm or suicide. Professor Monckton Smith presents a systematic narrative analysis of perpetrators behaviours and methods that reveal the sequence of events that precede intimate partner homicide and suicide.
