Gambling Harms Awareness Week



On the 12th – 16th June Public Health & Protection will be piloting a **Gambling Harms Awareness Week** in Cumbria, whereby frontline organisations will carry out additional screening with clients and making referrals for support to the Beacon Counselling Trust (BCT) as appropriate. To complement the Awareness Week, there are two free training sessions on offer to those working in

public facing roles and professionals working with young people which are provided by BCT.

Bet You Can Help Now! - 13th June 2023 10:00-11:15 - MS Teams link: Click here to join the meeting

Bet You Can Help Now is one hour fifteen minute condensed training workshop that features the key elements of the tackling gambling harms first aid approach. This course is aimed at people who may be restricted in the ability to attend the full

day programme, but wish to use the core elements within their professional practice. The objectives of the Bet You Can Help Now! module are:

- Learners will develop their knowledge and understanding of gambling related harms
- Learners will have increased confidence in implementing effective screening and interventions with those at risk of gambling related harms
- Learners will be aware of and understand the appropriate levels of support available to help and support those affected by gambling related harms

This workshop is appropriate for professionals in any public facing role.

Young People's Gambling Harm Prevention Programme - 15th June 2023 10:00-11:30 - MS Teams link: Click here to join the meeting

This training session is aimed at any professionals working with young people aged 10 to 19 looking to find out more about how gambling harms can affect young people and the wider family. This session looks at defining gambling and gambling related harms whilst examining how gambling affects the brain, alongside the role of digital harms and the presence of gambling within gaming. We also look at how we can identify gambling harms and the specialist treatment and support services available to support young people.

Ghosts in the Nursery - One Day Training

This is a free one-day online training aimed at early years professionals, social workers, and mental health workers will look at the work with parents who are haunted by unresolved issues from their past, known as 'ghosts in the nursery' and how issues will unconsciously influence the way they think and behave toward their children.



Some parents, based on their early experiences, might well have developed defences to shut off from their vulnerability and feelings of love, which makes it very difficult for them to bond with their baby or young child. As practitioners, an awareness of a parent's ghosts, even if we are not trained to work directly with these issues, can equip us to understand more fully and respond to parents in an attuned way. With complex families, our understanding is likely to increase our capacity to form a meaningful, therapeutic alliance with parents who are otherwise hard-to-reach.
