## **Foreword**

### What is Domestic Abuse?

Under the Domestic Abuse Act 2021, Domestic Abuse consists of the following between two people aged 16 or older who are 'personally connected' in that they are or have been in an intimate personal relationship or those who are related.

- physical or sexual abuse;
- violent or threatening behaviour;
- controlling or coercive behaviour;
- economic abuse;
- psychological, emotional or other abuse;

The definition recognises children as victims of domestic abuse if they see, hear or otherwise experience the effects of abuse and are related to either the abuser or the abused.

The following is a guide to Domestic Abuse Services in Cumbria, including training opportunities, available services-referral mechanisms, and annual reports.

Domestic Abuse is everyone's business. If someone is at risk, or a crime is in progress, always dial 999.

## Accommodation for Victims of Domestic Abuse

### A Quick Guide

Under the Domestic Abuse Act 2021, there is a duty to accommodate and support victims of Domestic Abuse, including children.

The aim is to stabilise the service user, so they are in a position to move into permanent accommodation and recover from their experiences. Each person is allocated a Domestic Abuse Supported Accommodation Officer to act as a Lead Professional to bring in all required services including mentoring, life skills and therapeutic services.

### Responding Well - Multi-agency Domestic Abuse Training

Learning outcomes:

- Define Domestic Abuse with an update on the DA Act 2021 and the changes to current practice/legislation.
- Ensure a thorough understanding of controlling and coercive behaviours and how abusive relationships develop.
- Explore typologies of abuse using Michael Johnson's model and consider how this impacts our assessment of risk and intervention for families.
- Understand the importance of risk assessment- using tools such as the DASH risk assessment and the importance of Professional Judgement.
- Identify how trauma impacts survivors and how we can work in a more trauma-informed way.

- a confidential helpline offering practical and emotional support. This is the route to which many of our referrals are received and all signposting to other agencies and support services are made.
  - one-to-one assessment of need where client and counsellor decide which counselling support service pathway (group sessions, one-to-one sessions or both) is most appropriate for themselves, and their family
  - one-to-one and individual counselling for victims, perpetrators, and children/ young people. We also offer EMDR therapy for victims suffering from PTSD.
  - befriending and support service (including pre counselling sessions- provided to clients on the waiting list that feel they need immediate support including emotional support, legal advice, attending courts, helping with transport)
  - a rolling programme of group sessions with adult victims/survivors.
  - a rolling programme of group sessions for children (primary age and under)
  - a rolling programme of group sessions for older children/young people (secondary age up to 18)

  - One-One Professional Counselling (victims, perpetrators and children and young People)
  - Group Work for Children and Young People (CYP)

- 166 girls/young women accessed support from the Pause, for thought programme

We supported a number of men (23) with a range of issues but none whose primary issue was domestic abuse in the last 12 months. In addition, we offered ongoing support for 11 fathers/step-fathers/carers of girls/boys attending the young people's programmes.

Many of the young people accessing our group programme and one to one support are affected by domestic abuse in their family or personal relationships.

Programmes available for victims and survivors of domestic abuse are as follows:

- Butterfly Project – a six week course too enable women to explore the different types od abuse and the effect it can have on them and their family
- My Relationships & Me – a six week course to help women understand and identify healthy and unhealthy relationships
- One to one support – individual support for victims and survivors of domestic abuse available in person at our Barrow Centre or Kendal Town Hall, or via phone/online for those who would prefer. A blend of the two is also available
- Crisis room – a safe space within the Barrow Centre is available during reception opening hours
- Accommodation & Support Service – a joint programme with Westmorland & Furness Council, Furness Homeless Support Group & Women's Community Matters. Safe accommodation is provided by FHSG with wrap around holistic support provided by WCM (including several one-to-one appointments per week, groups, activities, socialising opportunities)
- Cumbria Domestic Abuse Survivors' Network – Established in early 2022 this contracted service is a countywide network of enabling the lived experience of survivors of domestic abuse to directly shape the design, delivery and development of domestic abuse services and related services at a local level. 16 women, 1 man and 4 people from the trans/non-binary community have engaged with the network in the 12 month period

Our waiting list for victims/survivors of domestic abuse is separate from the waiting list for other elements of our service. It changes on a daily basis. The crisis room supports those who are fleeing and these are helped on the same day alongside partner agencies. All those needing/wanting urgent support are seen on the same day, others wait a maximum of 48 hours. There are a small number of women who wait a little longer by mutual agreement where they are not at risk and who waited a maximum of 2 weeks during the year 2022-23.

Safety Net (UK) is a specialist organisation that supports the recovery of those affected by rape, exploitation, sexual and domestic abuse, we support CYP and adults.

We provide:

- Tier 1: Short term information, advice, advocacy, and helpline. Providing advice around court procedures, pre-trial advice, and support, linking you in with and liaising with other agencies and services, as well as advice and support to professionals and family members (up to 3 sessions).
- Tier 2: Trauma-informed support - providing short-term safety and stabilisation work. As well as practical support with housing, benefits, court procedures and your health needs, our specialist trained practitioners work with clients on strategies to improve safety and ability to cope. This can include mindfulness and relaxation, sleep, and self-care techniques, as well as psychoeducational work on the impact trauma has on the brain and on the body. (Up to 12 sessions on average.)
- Tier 3: Counselling and therapeutic support. We have a team of specialist trained therapists and counsellors who work within a trauma-informed model. Our counsellors and therapists provide a safe, trusting, non-judgemental and confidential space where you can build a therapeutic relationship with your counsellor to explore how the rape and/or domestic or sexual abuse is impacting your life now. The duration of this support is adjusted according to need (Max of 20-25 sessions on average.)
- Tier 4: Recovery community. We work in partnership with other charities, groups, gyms, and clubs to support integration back into the community, helping you to build social networks and

relationships. We also have peer mentors and befrienders to support you when you have finished therapy or support at Safety Net. Our work in this area includes an arts and crafts group, and a specific men's group, managed by volunteers, many of whom have been clients.

- Training, education, and awareness raising – Increased awareness of the psychological and emotional impact of domestic violence and sexual abuse through education and training.

**Services delivered including any programmes, detailing if they are available for men/ women/ non-binary/children/ families:** Refuge accommodation for women and children – women in refuge have access to trauma counselling through funding we have secured, community based support for women and men, support delivered in rural areas, ISAC, poverty support, support for friends and family of DA victims and survivors.

**Independent Victim Advocate team** – Domestic Abuse Independent victim advocates (DA IVAs) specifically work with DA victims & survivors aged 16+ who are referred to us with a Standard or medium risk grading from referring agencies. DA IVA will review risk and implement an Independent

Safety & Support plan much the same way as an IDVA would, monitoring for risk escalation and referring to MARAC as required.

**Independent Domestic Violence Advocates** (Including trained Independent Domestic & Sexual Violence Advocates IDSVAs ) IDVAs specifically provide crisis intervention, risk assessment, individual safety & Support planning and are able to advocate on behalf of victims/survivors who are deemed to be at high risk of harm.

**How to refer:** Submit your completed risk assessments and MARAC referral form to the MARAC coordinators. This generates a safe guarding hub referral to IDVAs.

**Children & Young person's DA recovery service** - Children & Young Peoples domestic Abuse practitioner team accept referrals from our own case workers in any dept, from the area Domestic Abuse Supported accommodation workers (Local authority DASAs) & any partner agency including schools, family support workers, Early help etc.

Our practitioners deliver stabilisation and recovery support to school age children who have experienced Domestic Abuse in the home. The programme is tailored to their needs and age related ability. Using a combination of Rock pool's Children & young people's recovery tool kit and roots to support. 1-1 sessions are provided with the children and young people with a view to improving their overall wellbeing, ability to cope and increasing their understanding of Domestic abuse.

They are dual trained to also provide CHIDVA support to young people under 16 in their own relationships who disclose domestic abuse. Assessing & monitoring risk and implementing safety & support plans much the same as IDVAs .

**Turning the Spotlight & They Matter perpetrator behavioural change programmes** – Turning the Spotlight's Healthy Relationships programme is best suited to situational couple violence & lower risk Domestic Abuse. It explores general awareness, stereotypes, relationships, love/sex, and spiralling video. Self-Awareness body cues, Red flags, cognitive triangle, Skills for change, taking responsibility, awareness of other people, thoughts and emotions, coping strategies. Education, self-awareness and skills for change.

They Matter is similarly structured & aimed at higher risk domestic abuse, it follows the same course but in much greater detail, with more one to one work.

**Domestic Abuse Recovery Toolkit (DART)**

The Recovery Toolkit is a trauma focused cognitive behavioural therapy programme. It is suitable for women not currently in an abusive relationship. The aim of the course is to empower participants with lifelong skills, tools and techniques to effectively make healthy relationships.

**Domestic Abuse Recovery Toolkit for Children & Young People (CHILD DART)**

The aim of the Children & Young People Domestic Abuse Recovery Toolkit is to help children and young people to become experts in their own recovery, allowing them to understand that they are not responsible for what has happened to them and for them to understand that they are not blamed for actions or decisions taken at the time of domestic abuse and to help them come to terms with their experiences.

The Recovery Toolkit for Children & Young People builds empowerment, feelings of self-efficacy and confidence and how to manage difficult emotions. Building positive relationships with family members and peers.

## Support for Perpetrators

**We have 3 Perpetrator Programmes in Cumbria.**



**Turning the Spotlight (TTS)** provides a RESPECT accredited holistic whole family approach to working with those causing harm and abuse, and situations where conflict within relationships is becoming or has the potential to become abusive. This is based on a 12 week healthy relationships group programme.

**They Matter** works with perpetrators of DA who have been assessed as a high risk of harm. The programme is 27 weeks and combines group and 1:1 work and will run until July 2025

All the services provided by Victim Support Cumbria are free and you do not need to have reported to the police, meaning Perpetrators of DA can access programmes without conviction

### **Step up- Restorative Solutions**

Step Up, a group programme for families experiencing youth violence in the home.

The overall aim of the programme is to support young people to stop violent and abusive behaviour, restore safety, trust and respect and to promote accountability to young people for their own behaviour in the home.

We aim to support families to leave the programme with a respectful family model established and new methods for handling problems and conflict that will prevent further re-offences of violence and abuse by young people who are being abusive.

Agreeing a family safety is a priority of the programme and we will develop a 'safety plan' with families followed by support to assess your young person's progress in staying non-violent and safe with family members.

Families are supported through a programme of interactive workshops during weekly 2 hour session sessions in a local venue. Sessions will be delivered as a whole 'Family' group and separate sessions with young people and parents/carers.

## **What is MARAC?**

A MARAC is a Multi-Agency Risk Assessment Conference. This is a weekly meeting to discuss how to help victims at high-risk of murder/serious harm.

The meeting allows the sharing of information and resources between agencies and professionals. This allows agencies to volunteer specialist actions/support – which create multi-agency risk management action plans. Together the attendees write an action plan for each victim.

The MARAC enables agencies to work together and share resources.

A referral to MARAC should be made if:

- 14 YES ticks on the DASH Risk Assessment
- OR
- Professional Judgement- Use your professional judgement in conjunction with the DASH risk indicators to assist in identifying and grading the risk.
- Anyone aged 16 or over can be referred to MARAC. The government definition of domestic abuse acknowledges that young people can be both victims and perpetrators.

If the DASH does not meet the threshold for MARAC, you should consider safety planning, referral to relevant agencies in order to best support the person.

Please remember - the DASH is a live document and should be completed with any increase or decrease in risk or every three months as good practice.
