

Nightstop Referral Form

The information in this form helps determine whether the person is suitable for Nightstop. At the start of each section, we explain why we collect that information, and who we share it with – please always read that to the referred person too.

In addition please share the following statement with the person that you are referring to Nightstop;

When we receive referrals to Nightstop, we collect personal and sensitive information about you. You have a right to know who has access to personal information about you, and who it is shared this.

On Nightstop, we ask for various pieces of information to:

- Help assess whether you're suitable for Nightstop
- Ensure it's safe for you, and for our volunteers
- Monitor trends about who uses Nightstop. This is to help us improve the service, and know more about who we help

We take good care of your details and they are always safe with us. We store all this information on our secure server and database, and only Prevention Services Team at Depaul UK/Nightstop North East and Cumbria have access to your personal information. If you are not suitable for Nightstop, we remove your data after 18 months.

You can find out more about how we use and store your data by speaking with the Project Manager or Senior in the Nightstop team.
