

## CUMBRIA COUNTY COUNCIL

Notice is given in accordance with section 19(1) of the Education and Inspections Act 2006 that Cumbria County Council intends to make a prescribed alteration to ARMATHWAITE COMMUNITY SCHOOL, Armathwaite, Carlisle CA4 9PW from 01 September 2011.

Cumbria County Council wishes to create a primary school from the existing Armathwaite 'first' school by changing the age range from 4-8 to 4-11

The proposal will start to be implemented on 1 September 2011 when a year 4 group will be established at the school. On 1 September 2012 a year 5 group will be established. The proposal will be fully implemented on 1 September 2013 when a year 6 group will be established.

The current capacity of the school is 68 and the proposed capacity will be 68. The current admission number for the school is 10 and the proposed admission number will be 10.

On 1 September 2011 pupils who would have transferred from the school will instead remain when the current year 3 group will become the first year 4 group. No pupils will be admitted to year 5 until 1 September 2012 and none to year 6 until 1 September 2013. While each year group will be restricted to 10 pupils the Authority will allow all pupils on roll at the school on 31 August 2011 to progress through the school until they reach year 6.

### **Explanatory Notes**

1. Cumbria County Council is proposing to make a prescribed alteration to Armathwaite School by extending the age range from 4-8 to 4-11 to change it from a 'first' school into a full primary school.
2. From 1 September 2011 it is intended that a year 4 group for children age 8 and 9 will be created at Armathwaite School. Pupils who would normally have transferred from the school on that date will be able to remain there.
3. Should any parent wish to transfer their children to year 4 at High Hesket School on 1 September 2011 the Authority would enable this to happen. Furthermore, the Authority would provide home to school transport in accordance with its home to school transport policy for those pupils that transfer on 1 September 2011 and those currently attending High Hesket School who live in Armathwaite catchment area that would have expected to receive home to school transport from that date.
4. No children will be admitted to year 5 at Armathwaite School until 1 September 2012 and into year 6 until 1 September 2013.
5. The capacity of Armathwaite School increased from 32 to 68 following completion of the new hall in 2010. This freed up an existing space that is now used as a classroom. This notice therefore confirms that increase in pupil capacity.
