Notice is given in accordance with section 19(1) of the Education and Inspections Act 2006 that Cumbria County Council, School Organisation Team, Parkhouse Building, Lower East Wing, Kingmoor Business Park, Carlisle, Cumbria. CA6 4SJ intends to make prescribed alterations to;

- Brook Street (Community) Primary School, Edward Street, Carlisle, Cumbria. CA1 2JB from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the Published Admission Number (PAN) by an additional 15 places from 30 to 45. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity of the school is 189 and the proposed capacity will be 315. The current number of pupils registered at the school is 175. The current admission number for the school is 30 and the proposed admission number will be 45.
- Petteril Bank (Community) Primary School, Burnett Road, Carlisle, Cumbria. CA1 3BX from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 15 places from 15 to 30. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 105 and the proposed capacity will be 210. The current number of pupils registered at the school is 94. The current admission number for the school is 15 and the proposed admission number will be 30.
- St Cuthbert's Catholic (Voluntary Aided) Primary School & Nursery, Victoria Road, Carlisle, Cumbria. CA1 2UE from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 7 places from 23 to 30. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 154 and the proposed capacity will be 210. The current number of pupils registered at the school is 106. The current admission number for the school is 23 and the proposed admission number will be 30.
- Upperby (Community) Primary School, Uldale Road, Carlisle, Cumbria. CA2 4JT from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 20 places from 40 to 60. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 266 and the proposed capacity will be 420. The current number of pupils registered at the school is 257. The current admission number for the school is 40 and the proposed admission number will be 60.
- Yewdale (Community) School and Nursery, Yewdale Road, Carlisle, Cumbria. CA2 7SD from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 25 places from 35 to 60. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 245 and the proposed capacity will be 420. The current number of pupils registered at the school is 244. The current admission number for the school is 35 and the proposed admission number will be 60.
- Robert Ferguson (Community) Primary School, East Dale Street, Carlisle, Cumbria. CA2 5LA from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 15 places from 45 to 60. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 315 and the proposed capacity will be 420. The current number of pupils registered at the school is 283. The current admission number for the school is 45 and the proposed admission number will be 60.
- Newtown (Community) Primary School, Newtown Road, Carlisle, Cumbria. CA2 7LW from 01 September 2012 and 01 September 2014. The proposal is to be implemented in stages. The first stage is to expand the PAN by an additional 15 places from 15 to 30. The second stage is that the school will be enlarged on the current site with a proposed implementation date of 01 September 2014. Current capacity is 105 and the proposed capacity will be 210. The current number of pupils registered at the school is 97. The current admission number for the school is 15 and the proposed admission number will be 30.

Cumbria County Council is proposing the above changes to Carlisle schools. These proposals have been published together in this one Notice as they are part of the transforming learning process in Carlisle. The proposals are not, however, related to each other, and will be treated as discreet proposals in the decision making process.

The schools will gradually increase their maximum capacity by accepting increased reception intakes each year from 1 September 2012. The higher year groups already on roll at the school will not increase in size.

No new site or additional site is required for any of these proposals.

The current capacity, current admission numbers and current numbers of pupils registered at each of the schools are set out above.

Explanatory Notes

1. Cumbria County Council also intends to make changes to the below schools, however, these changes do not require the publication of a statutory notice. These schools are also part of the transforming learning process in Carlisle;

- Inglewood Infant (Community) School, School Road, Harraby, Carlisle, Cumbria. CA1 3LX from 01 September 2012: is to expand the PAN by an additional 6 places from 84 to 90.
- Inglewood Junior (Community) School, Arnside Road, Harraby, Carlisle, Cumbria. CA1 3QA from 01 September 2012: is to expand the PAN by an additional 15 places from 75 to 90.

2. All objections and other comments made (and not withdrawn in writing) within the representation period will be sent in full to Cumbria County Council's Cabinet. The final decision on whether or not to implement these proposals will be made using guidance provided by the Department for Education, by the Cabinet of Cumbria County Council within 2 months of the end of the representation period.

3. The proposed implementation date of the second stage enlargement of the above schools is 1 September 2014; this is the proposed date to complete all of the transforming learning process in Carlisle.
