

Change of Age Range Consultation - Irthington School

Introduction

Between 18th June and 30th July 2012 Cumbria County Council conducted a consultation exercise seeking the views of stakeholders and the local community on the possibility of a change of age range at Irthington Village School. The proposal would allow Irthington School to change from its current 4-11 age range to a 3-11 age range school.

Summary of Responses

A total of 47 people responded during the consultation period. 38 were in the form of completed questionnaires received by post, 7 were questionnaires completed online and 2 were submissions to the consultation sent by letter. Those responding included a school governing body, parish councils, councillors, the proprietor of local nursery and the headteacher of a local school. In addition there were also separate responses from the children of Irthington Village School (see attached summary).

Overall 96% (45) of respondents supported the proposal to change the age range of Irthington Village School and 4% (2) did not state a preference (one person replied via a letter not stating a preference, the other replied by way of questionnaire and did not tick a response box).

40% (19) of all respondents are parents. 17% (8) are prospective/nursery parents. 2% (1) of respondents are a school governing body, 13% (6) are governors, and 17% (8) are staff. 30% (14) of respondents were not parents, staff or governors. Figures may not add up to 100% as multiple categories were selectable.

54% (25) of respondents who stated an address were within the catchment area of the school (the others were mainly from Crosby on Eden CE, Fir Ends, Lees Hill CE and Warwick Bridge catchments).

Do you support the proposal for change of age range to establish a maintained nursery provision?

45 respondents answered this question from the total of 47, and were all in favour of the proposal.
