The report provides examples of some of the national and local funds that are currently open for applications that may be of relevance to the work of your voluntary sector early years childcare organisations.

### **Happy Childhood Fund**

The ethical, organic baby and children's clothing company Frugi has launched the Happy Childhood Fund. Its aim is to improve the lives of vulnerable children living in poverty in the UK. Applications are welcome from UK registered charities working with children and communities in any of the following three areas to apply:

Hunger – Food banks, Community kitchens, Holiday hunger

Shelter – Homelessness, Community Centres, Foster Care

Nature – Community gardens, Parks and playgrounds, Experiences of nature.

Applications from grassroots charities of any size are welcome. The maximum award is £5000 and the fund looks to prioritise costs of delivering projects rather than organisational running costs.

### **Coronavirus Community Support Fund – England**

You can apply if your organisation is a:

- voluntary or community organisation
- registered charity
- constituted group or club
- not-for-profit company or Community Interest Company

What can be funded?

Through the Coronavirus Community Support Fund we can fund:

- Activities supporting people and communities affected by COVID-19 and/or
- Organisations to overcome any acute financial difficulties they're facing because of the pandemic

Organisations can apply for between £300 - £10,000 and over £10,000 to cover up to **six months** of costs. We are asking people to only apply for what they need and expect most grants to be under £100,000.

What can be funded?

- your organisation's running costs
- essential items for food banks
- small land or refurbishment projects that can be delivered within Government guidelines
- equipment
- one-off events
- staff costs
- training costs
- transport
- utilities/running costs
- volunteer expenses
- Organisational development

## **Ragdoll Foundation**

The Ragdoll Foundation's Open Grants Scheme supports the cultural sector's work with children and young people. The vision of Ragdoll Foundation is to support quality arts engagement projects where the concerns of childhood can be heard. Priority will be given to innovative arts-based projects that share the same values of imagination and creativity as the Ragdoll Foundation and, in particular, projects which have a deep commitment to listening to children and young people and allow their perceptions and feelings to be understood. Although most applicants will be an arts organisation, other not for profit organisations which intend to partner with arts organisations or work with artists within their project will be considered.

There are two strands to the Scheme:

Small Grants (for grants of up to £1500)

Main Grants (for grants between £5000 and £20000)
