Local Government Review - Safeguarding

On 1 April the Cumbria-wide Safeguarding Hub was replaced by the Cumberland Safeguarding Hub and Westmorland and Furness Safeguarding Hub.

Local Authority Designated Officer – LADO

Cumbria LADO service continues to cover both local authority footprints - Cumberland and Westmorland and Furness.

If you have concerns regarding someone who works with a child, these should be reported to the LADO. This applies to all paid, unpaid, volunteers, casual, agency employees or anyone working in a self-employed capacity.

Information on LADO including how to contact and the referral form will still be accessed via the **Cumbria Safeguarding Children Partnership (CSCP) website.**

Cumbria Safeguarding Children Partnership

Cumbria is maintaining a single safeguarding children partnership which will cover both new local authorities.

Keeping Children safe in education

Coming into effect on 1 September 2023, the guidance outlines the legal obligations for schools and trusts to safeguard and promote pupil welfare, with limited changes from previous versions.

Notably, there is increased emphasis on the significance of filtering and monitoring IT systems. Governing boards are advised to align their child protection policy accordingly and update it annually to reflect the new guidance.

We advise that governors and trustees undergo annual training and stay informed about important updates throughout the year. To support this we encourage all governors and trustees to complete Safeguarding: how to fulfil the governance role - **NGA Learning Link module.** In addition, you may find the follow resources useful:

Ofsted Inspections

Ofsted inspection timings for schools, this blog post helps to clarify when schools can next expect their next inspection.

Changes made to school inspections, Ofsted has announced changes to improve aspects of its work with schools.

Changes to Ofsted's post-inspection arrangements and complaints handling: proposals 2023, consultation on proposed changes to Ofsted's post-inspection arrangements, including how Ofsted handle complaints about their work.

Sustainability leadership and climate action plans in education

Ahead of strategic planning for the next academic year, the Department for Education (DfE) have published basic guidance on sustainability leadership and climate action plans, which is details the role governors and trustees can play in supporting environmental sustainability in education.

The National Education Nature Park and Climate Action Award scheme, led by the Natural History Museum partnership, will also be launched in the Autumn. The programme will provide opportunities for more outdoor learning for all children and young people.

In addition, the DfE has **announced** funding of £15 million to help young people in disadvantaged areas to learn outside and experience nature.

School suspensions and permanent exclusions

DfE guidance on the suspension and permanent exclusion of pupils from Local Authority maintained schools, academies and pupil referral units, including pupil movement'. This guidance applies from 1 September 2023.

School exclusions: guide for parents

DfE have produced a guide to support parents and carers whose children attend a maintained school, pupil referral unit. academy school and alternative provision academy in England. This guidance applies from 1 September 2023.

School uniforms: guidance for schools

DfE have updated their **guidance** with the addition of a link to the Equality and Human Rights Commission guidance on 'Preventing hair discrimination in schools'.

Training

Training on Independent Review Panels for Permanent Exclusions

The Legal Services Department at Westmorland and Furness Council are offering a training course on Independent Review Panels for Permanent Exclusions. The training course is open to all school staff, local authority employees and panel members involved in independent review panels.

For school's signed up to the Legal Services SLA (Service Level Agreement) the training is free of charge. For those not signed up there is a fee of £50.00 per delegate (plus VAT is applicable).

Included in the training will be an overview of the exclusion process from Head Teacher exclusion through to the Independent Review Panel, including:

- Recent legal updates
- The exclusion process and appeals
- What information should be included in the exclusion papers
- How to present your case to a review panel
- Equality and SEN considerations
- IRP roles and the decision-making process

School Complaints

It is important that governors know and understand their School Complaints policy and that policy, for LA maintained schools must be on the school's website, for academies, DfE recommend publishing on the school website. It is also vital that the procedure is reviewed regularly, DfE recommend annually.
