NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by Robert Bryce Hasell-McCosh ("the Applicant") to Cumbria County Council as commons registration authority, under Section 19 (2) paragraph (a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to the boundary between common land register unit CL160 Deepdale Common and CL57 Grisedale Forest (shown edged red on the attached plan).

A summary of the effect of the application is as follows: Application No. 115 was submitted to the Commons Registration Authority on 15<sup>th</sup> December 1967 by Mrs. Sylvia Mary McCosh to register Grisedale Forest as common land. Grisedale Forest was provisionally registered as CL57 on 22<sup>nd</sup> March 1968. Subsequently Application no. 1398 was submitted to the Commons Registration Authority 25<sup>th</sup> June 1968 by Mr. Anthony Clifford Brown, to register Deepdale Common as common land. Deepdale Forest was provisionally registered as CL160 on 8<sup>th</sup> April 1970. The two registrations were in conflict with each other with regard to the boundary between the two commons and the matter was referred to the Commons Commissioner. At a hearing held on 12<sup>th</sup> March 1982 the Commons Commissioner made a decision as to the boundary between Deepdale Common and Grisedale Forest and a plan showing the agreed boundary was produced. The applicant seeks to amend the registered boundary between CL160 Deepdale Common and CL57 Grisedale Forest in accordance with the Commons Commissioner's decision.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by preparing a fresh edition of the register map showing the boundary between Deepdale Common and Grisedale Forest amended in accordance with the 1982 Commons Commissioner's decision.

Any person wishing to make representations:

- must quote the Application No. CA10/5
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 25th April 2016

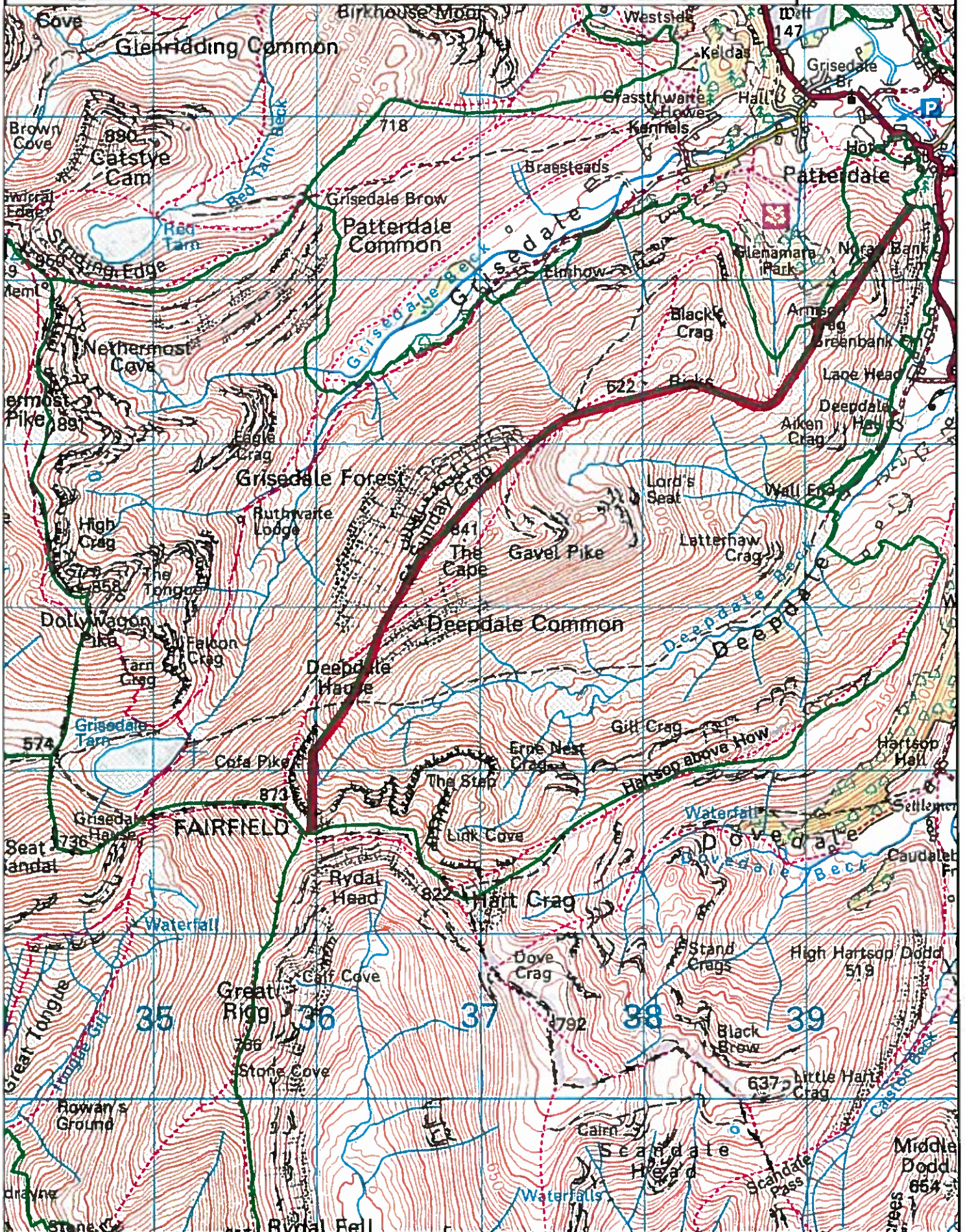

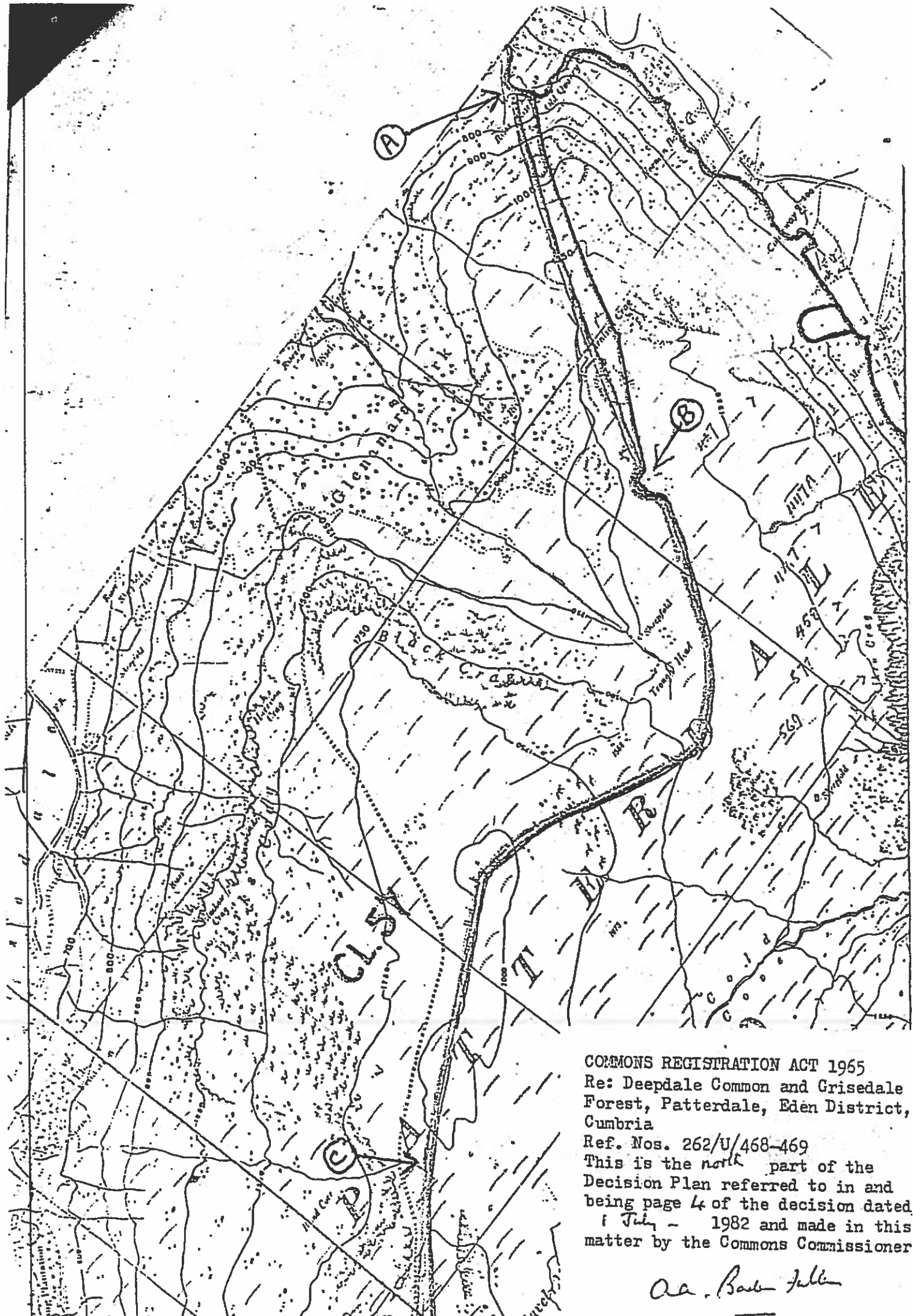

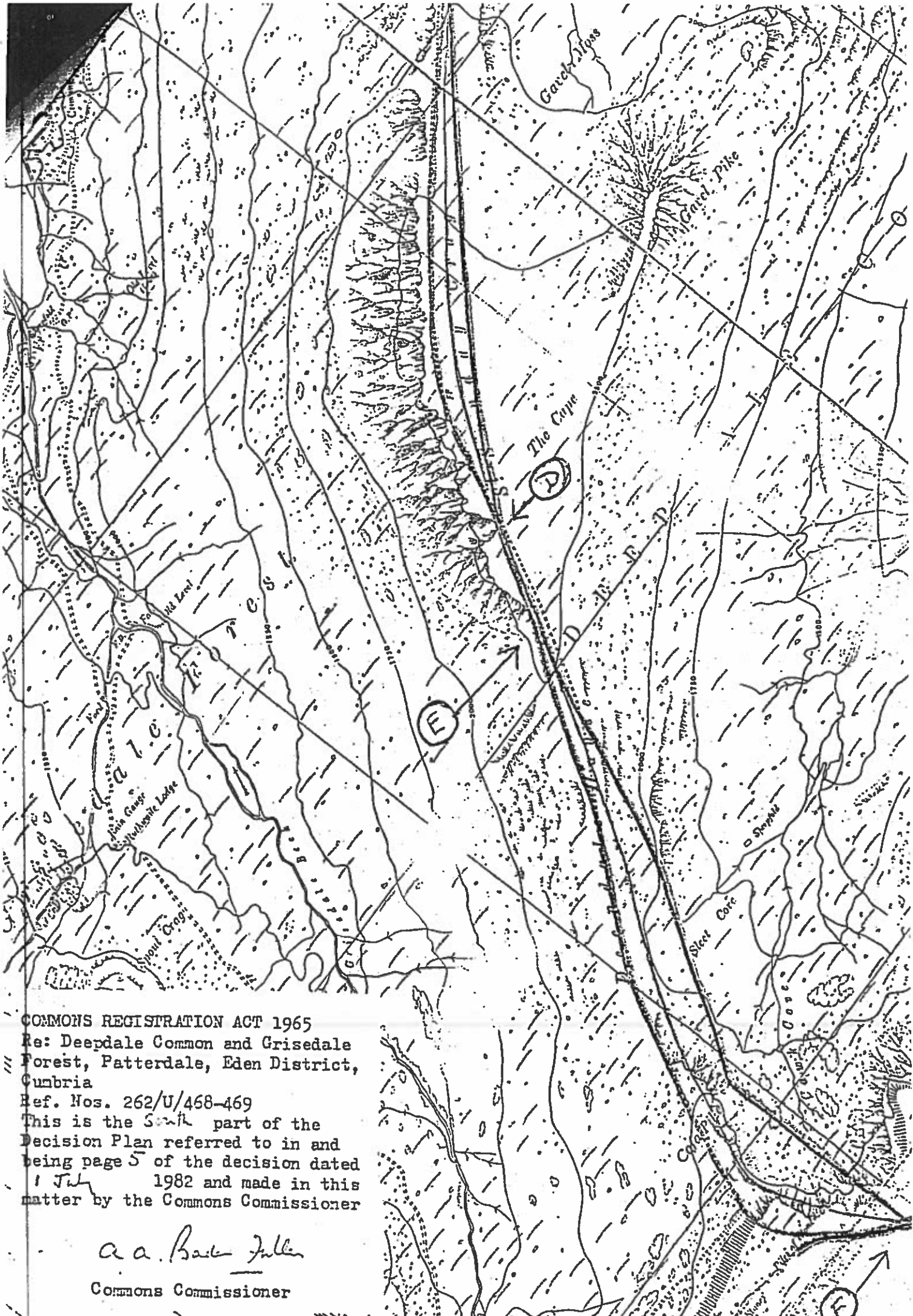
**CA10/5 Application to correct the register
