NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Mr Neil Richard Fell** to Cumbria County Council as Commons Registration Authority, concerning the right on CL70 - Burgh Marsh described more fully below.

A summary of the effect of the application is as follows: The right to graze 4 stints (one stint equaling one beast or 2 1/2 sheep between 1<sup>st</sup> May and 28<sup>th</sup> October; sheep only to be grazed between 8<sup>th</sup> November and 28<sup>th</sup> March) and the right in the soil to cut turf and such rights of piscary as may be appurtenant thereto on Burgh Marsh comprising the whole of the land in this register unit is currently registered as held in gross at Entry 308 of register unit CL70 in the name of Mr Neil Richard Fell of the 1 East View, Meadowfield, Co Durham, DH7 8RY. Mr Fell's address changed to Nafferton Farm Cottage, Bracepeth, Durham, DH7 8EF and by this application he seeks to record his new address in the Register.

If the application is granted, the registration authority will give effect to the determination by amending the Register to show Mr Fell's new address in column 3.

Any person wishing to make representations:

- must quote the Application No. CA10/22
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
