

**Commons Act 2006 – Schedule 3
NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT**

Notice is hereby given that an application has been made by **Thomas John Dixon** (“the Applicant”) to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL125 Ousby Fell.

A summary of the effect of the application is as follows: The right to graze 200 sheep on Ousby Fell comprising the whole of the land in this register unit (“the Right”) is currently registered as attached to O.S. fields numbered 503, 505, 501, 357, 359, 498, 416, 417, 419, 413, 429, 432, 487, 484, 482, 64, pt.63, 402, 148, 245, 506, 145, 496 at entry 6 of register unit CL125 in the name of the Applicant. The Applicant claims that the proportion of the Right attached to O.S. field number 432 was severed from the land and retained by the Applicant upon the sale of the said field to Mr Peter Robinson Smith in 1981. The Applicant seeks by this application to register that severance in the register.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by deleting current entry 6 (making reference to new corresponding entries) and by making two new entries in the register to show the proportion of the Right currently attached O.S field number 432 as severed from the land and held in gross and the remainder of the Right as attached to the rest of the dominant tenement.

Any person wishing to make representations:

- must quote the Application No. **CA14/15**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 4th February 2016
