

**Commons Act 2006 - Section 19(2)(d)
NOTICE OF APPLICATION TO CORRECT THE REGISTER**

Notice is hereby given that an application has been made by **Thomas Henry Wales and Julie Wales** to Cumbria County Council as Commons Registration Authority, under Section 19(2)(d) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 41 of the common land register unit CL127 Kirkland Fell, entry 39 of the common land register unit CL323 Blencarn Fell and entry 37 of the common land register unit CL322 The Rigg, Blencarn.

A summary of the effect of the application is as follows: the following rights are attached to O.S. field numbers 131, pt230, 286, 284, 265, 210, 209, 207, 205, 246, pt247, 194, 195, 189, 181, pt180, pt179, 178, 183, 174, 190 and are exercisable over the whole of the land in register units CL323, CL322 and over the land south of ABCD in the register unit 127.

Entry 41 CL127 and entry 39 CL323

"The right to graze 271 ewes with followers, 181 hogs, 30 ponies and 15 head of cattle."

Entry 37 CL322

"The right to graze 286 ewes with followers, 191 hogs, 30 ponies and 15 head of cattle, the right of turbarry and cutting bracken."

The rights are registered in the name of Mr & Mrs T H Wales of Highfield, Blencarn, Penrith. Mr & Mrs Wales' address changed to 2 Netherend Road, Penrith, Cumbria, CA11 8PF and by this application they seek to record their new address in the register.

If the application is granted, the registration authority will give effect to the determination by amending the register to show Mr & Mrs Wales' new address in column 3.

Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;

Any representations made will not be treated as confidential. Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
