**NOTICE OF APPLICATION TO REGISTER A NEW TOWN OR VILLAGE GREEN**

Notice is hereby given that an application has been made by **Lazonby Parish Council** ("The Applicant") to Cumbria County Council as commons registration authority, concerning land at Scaur Close, Lazonby ("the Application Land") described more fully below.

The summary of the effect of the application is as follows: The Applicant, as the owner of the land, seeks to voluntarily register the land described in the schedule below as a town or village green.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by registering the Application Land as a new town or village green.

Representations:


- must quote the Application No. **CA9/2**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 17<sup>th</sup> January 2018.
