

## Commons Act 2006 - Section 19(2)(a) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Natland Parish Council** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit VG2 Natland Village Green.

A summary of the effect of the application is as follows: Natland Village Green was provisionally registered as village green on 16 August 1967, pursuant to an application made by Natland Parish Council dated 26 May 1967 and numbered 23 ("the 1967 Application"). The provisional registration of the 1967 Application became final on 17 December 1971. The Applicant claims that the land coloured red on the attached plan ("the Application Land") was included on the plan attached to the 1967 Application and the first edition of the register map but not on the second edition map and that the Commons Registration Authority made a mistake when the second edition map was drafted by wrongly omitting the Application Land from register unit VG2 Natland Village Green.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by including the application land as part of the legal map record, which will entail the addition of a registration amendment entry in register unit VG2 confirming the reinstatement of the land, and the amendment or preparation of a fresh edition of the register map showing all of the land contained in register unit VG2 as registered village green.

### Representations:

- must quote the Application No. **CA10/25**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and


Any representations will not be treated as confidential, to determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is 5pm on 17 March 2017.
