

Commons Act 2006 - Section 19(2)(a) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Marion Redhead** (“the Applicant”) to Cumbria County Council as Commons Registration Authority, under Section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL430 Hyton Marsh.

A summary of the effect of the application is as follows: Hyton Marsh was provisionally registered as common land on 5th May 1970 under Section 4 of the Commons Registration Act 1965, pursuant to an application made by Isaak Redhead dated 21st December 1969 and numbered 1921 (“the 1969 Application”). The provisional registration of the 1969 Application became final on 1st August 1972. The application asked for the right of pasturage for 100 sheep or lambs or 20 cattle and the right to water cattle to be registered over the land shown edged green on the attached plan and to be attached to the land edged red on the same plan (“the Application Land”). The registration authority registered both aforementioned pieces of land as common land. Applicant claims that the registration authority made a mistake in registering the Application Land as common land and seeks by this application to remove the Application Land from register unit CL430 Hyton Marsh.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register unit CL430 confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in register unit CL430 as registered common land and the Application Land marked as deregistered.


- must quote the Application No. **CA10/28**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations will not be treated as confidential, to determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is 5pm on 27th June 2017.
