

**Commons Act 2006 - Section 19(2)(b)
NOTICE OF APPLICATION TO CORRECT THE REGISTER**

Notice is hereby given that an application has been made by **Rowland Frederick Hart Jackson** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 19(2)(b) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register unit CL189 Bethacar Moor.

A summary of the effect of the application is as follows: An application to register the right to graze 296 sheep or 29 head of cattle or 18 horses was made on 2nd January 1970 and numbered 1300 ('the 1970 Application'). The 1970 Application described the land to which the rights were attached as Stock Farm, Nibthwaite, and included a plan to define this dominant tenement. The Applicant claims that two fields were erroneously included within the plan and they should therefore be removed from the dominant tenement. The two fields in question are marked on the adapted copy of the 1970 Application plan titled 'Plan No 2', provided by the Applicant and attached for reference. On inspection the two fields in question are also included in the dominant tenement of entry 15 relating to High Bethacar Farm creating a conflict.

If the application is granted the Commons Registration Authority will give effect to the determination by deleting current entry 12 (making reference to the new corresponding entry) and making a new entry in the register which would be accompanied by a supplemental map showing the newly defined dominant tenement with the two fields removed.

Any person wishing to make representations:

- must quote the Application No. **CA10/30**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. To determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is **5pm on 24th July 2017**

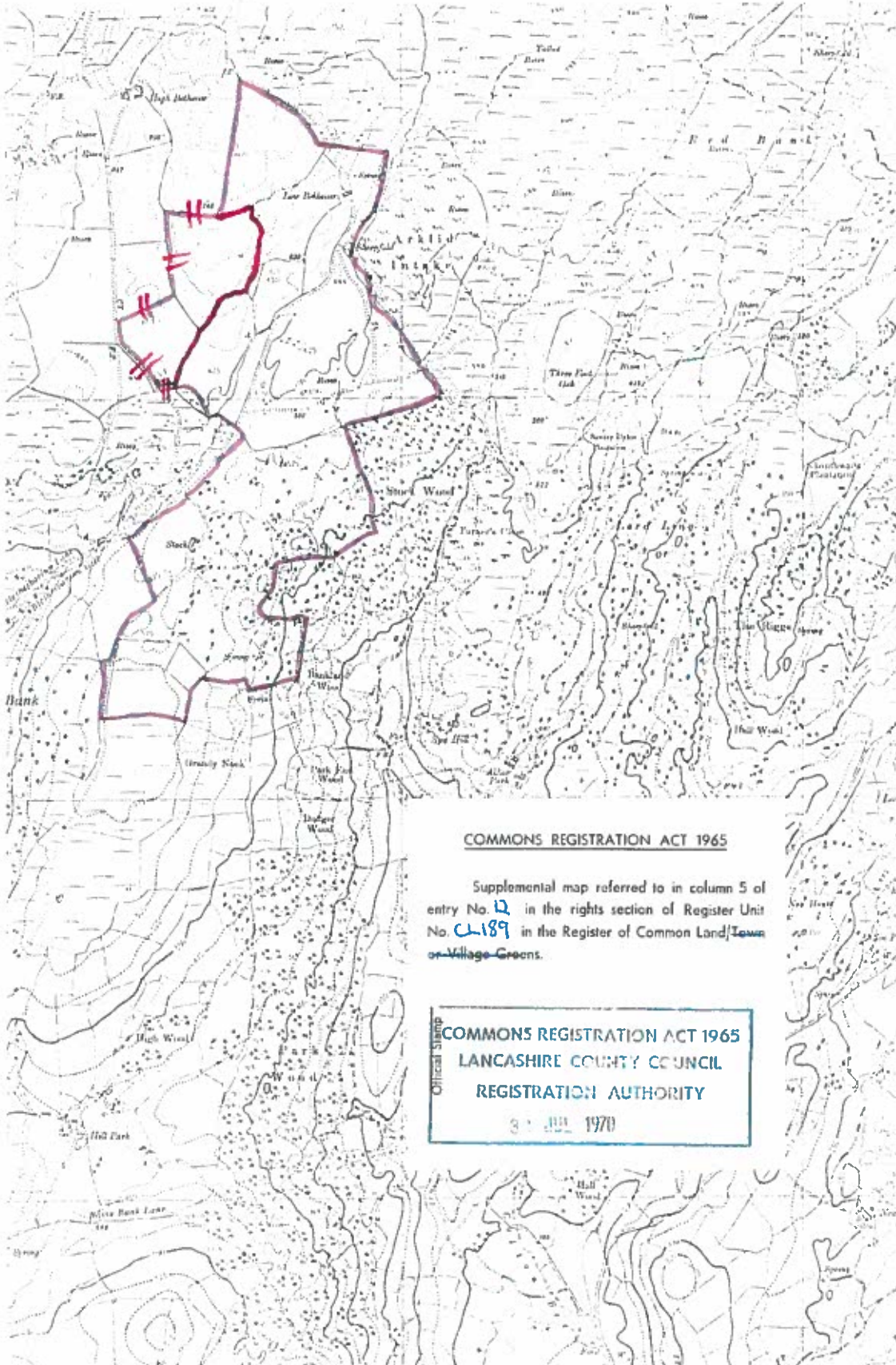
