

## Commons Act 2006 - Section 19(2)(d) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Mr David Jonathan Dixon (“the Applicant”)** to Cumbria County Council as Commons Registration Authority, under Section 19(2)(d) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to register units CL95 Hartley Fell and CL54 Helgill Howe.

A summary of the effect of the application is as follows: The right to graze: (a) 90 ewes with their followers and (b) 30 hogs over the whole of the land comprised in register units CL95 Hartley Fell and CL54 Helgill Howe is currently registered as attached to O.S. Nos 5024 and 7612 (O.S. Nos. 195 & 222 1915 edition) in the name of David Jonathan Dixon of Rakehead, Nateby, Kirkby Stephen, Cumbria. The Applicant’s address changed to Hartley Castle, Hartley, Kirkby Stephen, Cumbria CA17 4JJ and by this application he seeks to record his full name and new address in the Register.

If the application is granted, the registration authority will give effect to the determination by amending the Registers to show the Applicant’s full name and new address in column 3.

Any person wishing to make representations:

- must quote the Application No. **CA10/40**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. To determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
