

**Commons Act 2006 - Schedule 2 (6)**  
**Application to deregister any other land wrongly registered as common land**

Notice is hereby given that an application has been made by **Denise Chamberlain** ("The Applicant") to Cumbria County Council as Commons Registration Authority, under Schedule 2 paragraph 6 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to land at Tarn Close, Great Urswick, Cumbria LA12 0ST, shown edged red on the attached plan ("the Application Land") currently registered in the register of common land register unit CL38 Urswick Tarn, Great Urswick.

A summary of the effect of the application is as follows: the Application Land was provisionally registered as common land on 29<sup>th</sup> September 1967 under section 4 of the Commons Registration Act 1965, pursuant to application number 79 made on 15<sup>th</sup> September 1967 by the Urswick Parish Council. The provisional registration, being undisputed, became final on 1<sup>st</sup> October 1970. The Applicant claims that the Application Land has at all material times been covered by or within the curtilage of the building known as the Urswick United Reformed Church, Great Urswick, formerly the Urswick Church of Christ Meeting House. The Applicant claims that the Application Land was wrongly registered and has requested the removal of the Application Land from the commons register.

If the application is granted, in whole or in part, the commons registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register unit CL38 confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in register unit CL38 as common land and the Application Land marked as deregistered.

Any person wishing to make representations:

- must quote the Application No. **CA13/22**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential. To determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is **5pm on 15<sup>th</sup> February 2019**.
