

**Commons Act 2006 - Section 8
NOTICE OF APPLICATION FOR APPORTIONMENT OF RIGHTS OF COMMON**

Notice is hereby given that an application has been made by **Betty Sharp (1), Elizabeth and Russell Beck (2), Mary Walker (3) and Sarah Elizabeth Wilson (4)** ("The Applicants") to Cumbria County Council as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 7 of the common land register unit CL8. A summary of the effect of the application is as follows: The following right is attached to O.S. numbers 772, 765, 764, 763, 750, 751, 694, 749, 696, 698, 697, 736, 735, 707, 709, 710, 712, 606, 605, 719 and 602 and is exercisable over the whole of the land in register unit CL8 Bootle Fell.

"The right to graze 7 stints (1 stint equalling 5 sheep or 1 cow)" ("The Right").

Pursuant to the division of the land to which the Right is attached, the Applicants seek by their application to register apportionment of the Right appropriate to the parts of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 7 will be deleted and reference made to the new corresponding entries.
2. Addition of a supplemental map.
3. The following entries will be made to the rights section of the commons register to show the proportionate apportionment of the Right to the applicants (a), (b), (c) and (d):

Betty Sharp

a. The right to graze 3.50 stints (1 stint equalling 5 sheep or 1 cow) on Bootle Fell comprising the whole of the land in this register unit. The right is attached to O.S. field numbers 605, 606, 712, 709, 694, 750, 751, 763, 764, 765 and 772 coloured blue on the proposed supplemental map.

Elizabeth and Russell Beck

b. The right to graze 1.52 stints (1 stint equalling 5 sheep or 1 cow) on Bootle Fell comprising the whole of the land in this register unit. The right is attached to O.S. field numbers 749, 736 and 735 shown coloured green on the proposed supplemental map.

Mary Walker

c. The right to graze 1.23 stints (1 stint equalling 5 sheep or 1 cow) on Bootle Fell comprising the whole of the land in this register unit. The right is attached to O.S. field numbers 710, 707, 698, 697 and 696 shown coloured red on the proposed supplemental map.

Sarah Elizabeth Wilson

d. The right to graze 0.75 (1 stint equalling 5 sheep or 1 cow) on Bootle Fell comprising the whole of the land in this register unit. The right is attached to O.S. field numbers 719 and 602 as shown coloured yellow on the proposed supplemental map.


Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must state the grounds on which they are made and must be signed by the person making them;

Any representations made will not be treated as confidential, to determine the application it will be necessary for the authority to disclose information received from you to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5 pm on 30th September 2019.
