

## Commons Act 2006 - Schedule 2 (8)

### Application to deregister any other land wrongly registered as a village green

Notice is hereby given that an application has been made by **Clarence Bowman Smith, Elspeth Smith and Tony James Smith** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Schedule 2 paragraph 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to land and buildings at Cumrew Farm, Cumrew shown edged red on the attached plan ("the Application Land") currently registered in the register of common land register unit VG113 as part of The Village Green, Cumrew Village.

A summary of the effect of the application is as follows: the Application Land was provisionally registered as a village green on 12<sup>th</sup> June 1970 under section 4 of the Commons Registration Act 1965, pursuant to application number 1969 made on 31<sup>st</sup> December 1969 by Border Rural District Council. The provisional registration, being undisputed, became final on 1<sup>st</sup> August 1972. The Applicants claim that the Application Land has at all material times been covered by or within the curtilage of the building or buildings known as Cumrew Farm. The Applicant claims that the Application Land was wrongly registered and has requested the removal of the Application Land from the commons register.

If the application is granted, in whole or in part, the commons registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register unit VG113 confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in register unit VG113 as a village green and the Application Land marked as deregistered.

Any person wishing to make representations:


- must quote the Application No. **CA13/21**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and
- must be sent to: The Commons Registration Service, Lady Gillford's House, Petteril Bank Road, Carlisle, Cumbria, CA1 3AJ or email: [commons.registration@cumbria.gov.uk](mailto:commons.registration@cumbria.gov.uk)

Any representations made will not be treated as confidential. To determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The date on which the period for making representations expires is 17<sup>th</sup> July 2018.
