**THE FOLLOWING ADDITIONAL DOCUMENTARY EVIDENCE HAS BEEN SUBMITTED:**

1. 1814 ENCLOSURE AWARD FOR HAYTON PARISH. MAP AND TEXT  
Shows the public quarry, public watering place, and a public track through the woods to access these areas.
2. 1839 TITHE AWARD MAP FOR HAYTON PARISH  
Shows the full extent of the paths into the quarry area along the river.
3. 1892 BELL'S ROAD MAP OF CUMBERLAND  
Shows that there was a public route down to the public quarry, across the Gelt and up to Brampton.
4. 1901 OS MAP OF THE GELT WOODS AREA  
Shows that most of the paths applied for existed in 1901
5. 1925/1926 EDITION MAP USED BY CUMBERLAND COUNTY COUNCIL, SHOWS MOST OF THESE PATHS ON THE MAP.  
This map was stamped and distributed to Hayton Parish Council in the 1950s. It was used for the draft and final submission map when, under the National Parks and Access to the Countryside Act 1949, public paths were surveyed and prepared to be added to the Definitive Map as public rights of way
6. MAPS SIGNED BY THE HAYTON PARISH COUNCIL CLERK AND SURVEYORS IN THE 1950s WERE SUBMITTED TO CUMBERLAND COUNTY COUNCIL. These maps show a network of agreed paths that were submitted to be added to the Definitive Map as Public Rights of Way.

This DMMO application is also supported in writing, to Cumbria County Council, by Hayton Parish Council and there is no record of any plans or statutory declarations deposited with the surveying authority prior to September 2010 for this area of woods
