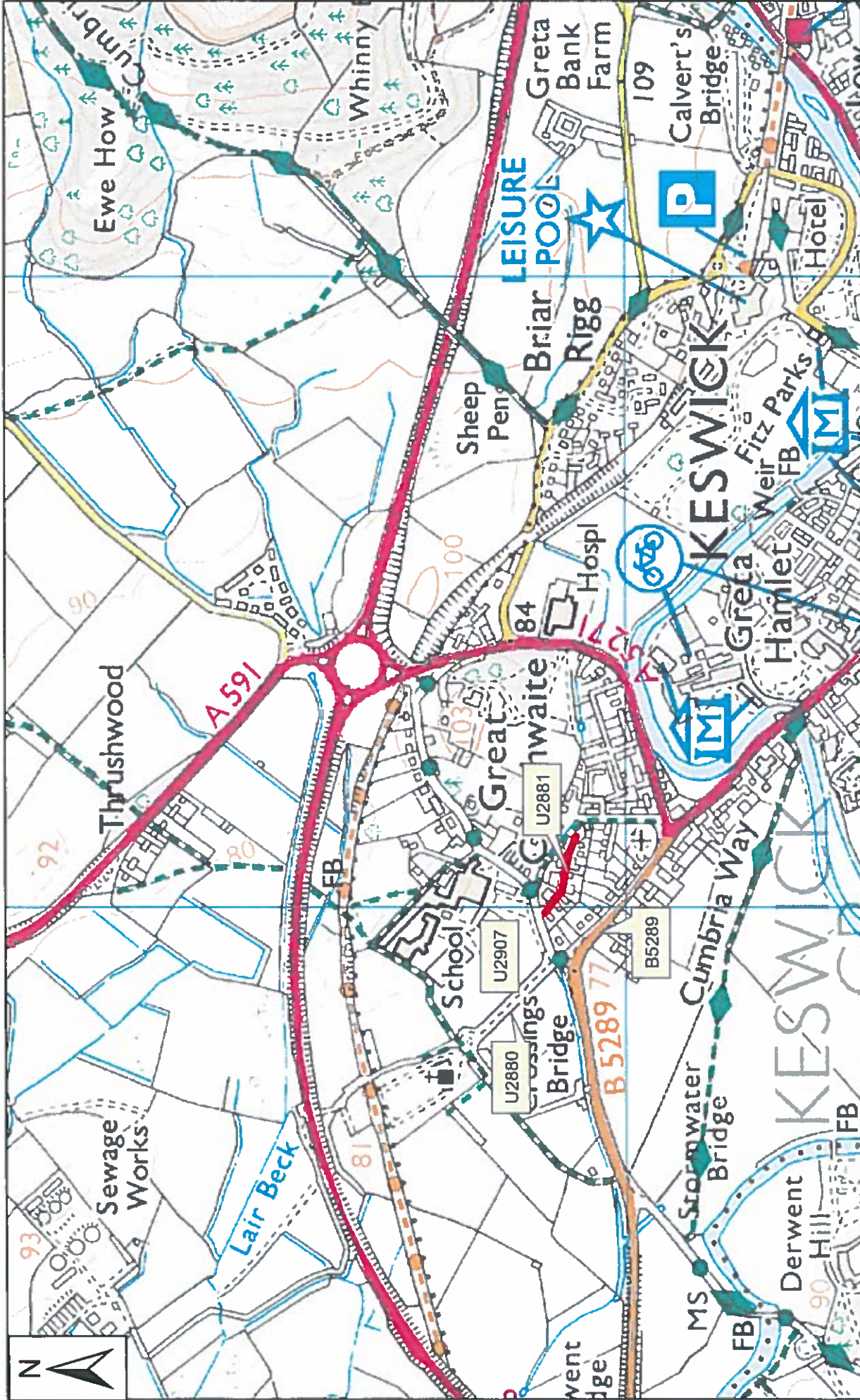

**NEW ROADS AND STREET WORKS ACT 1991**  
**SECTION 58**  
**NOTICE OF SUBSTANTIAL ROAD WORKS FOR ROAD PURPOSES**

1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.
2. The streets in which these works will take place are: U2881 Crosthwaite Gardens, Keswick, Cumbria
3. Work is expected to affect the carriageway on U2881 Crosthwaite Gardens
4. Work is expected to commence on: 01 September 2017 work should begin within three months of this date.
5. The works notified will include the following:

Grid Ref: 326035/524100

Carriageway Resurfacing –

U2881 Crosthwaite Gardens, Keswick, Cumbria from its junction with the  
U2907 in a Westerly direction for a distance of approximately 250 metres.

6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 3 years from completion of the works described in paragraph 5 without the consent of the said highway authority, which is not to be unreasonably withheld.
7. If any statutory undertaker has any planned work for this affected area and wishes to execute it before this restriction comes into effect they should, for the purpose of Section 55, give notice of their proposals within 20 days of this notice.
