1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.

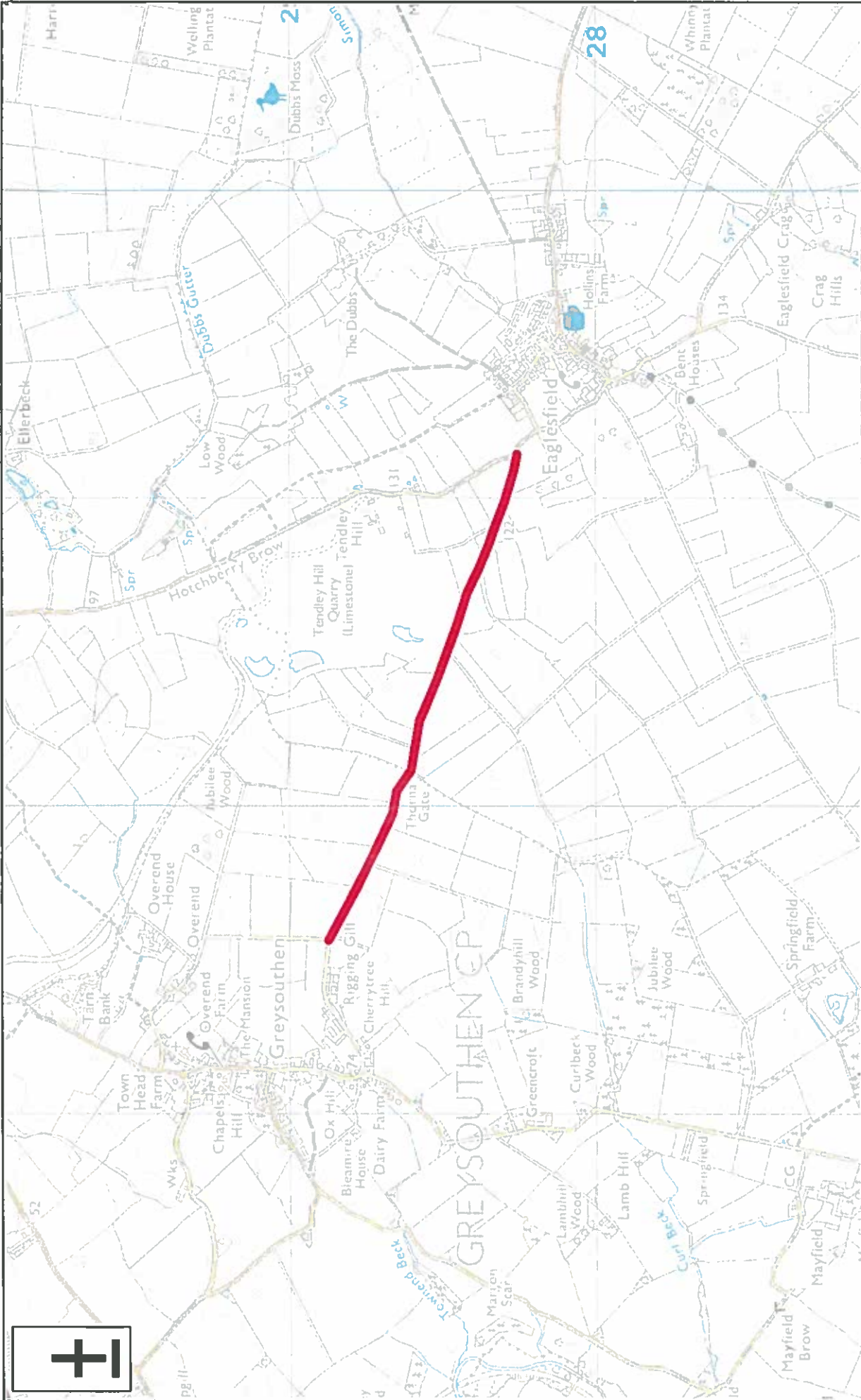
Description of Works – Carriageway Resurfacing
