NOTICE OF SUBSTANTIAL ROAD WORKS FOR ROAD PURPOSES

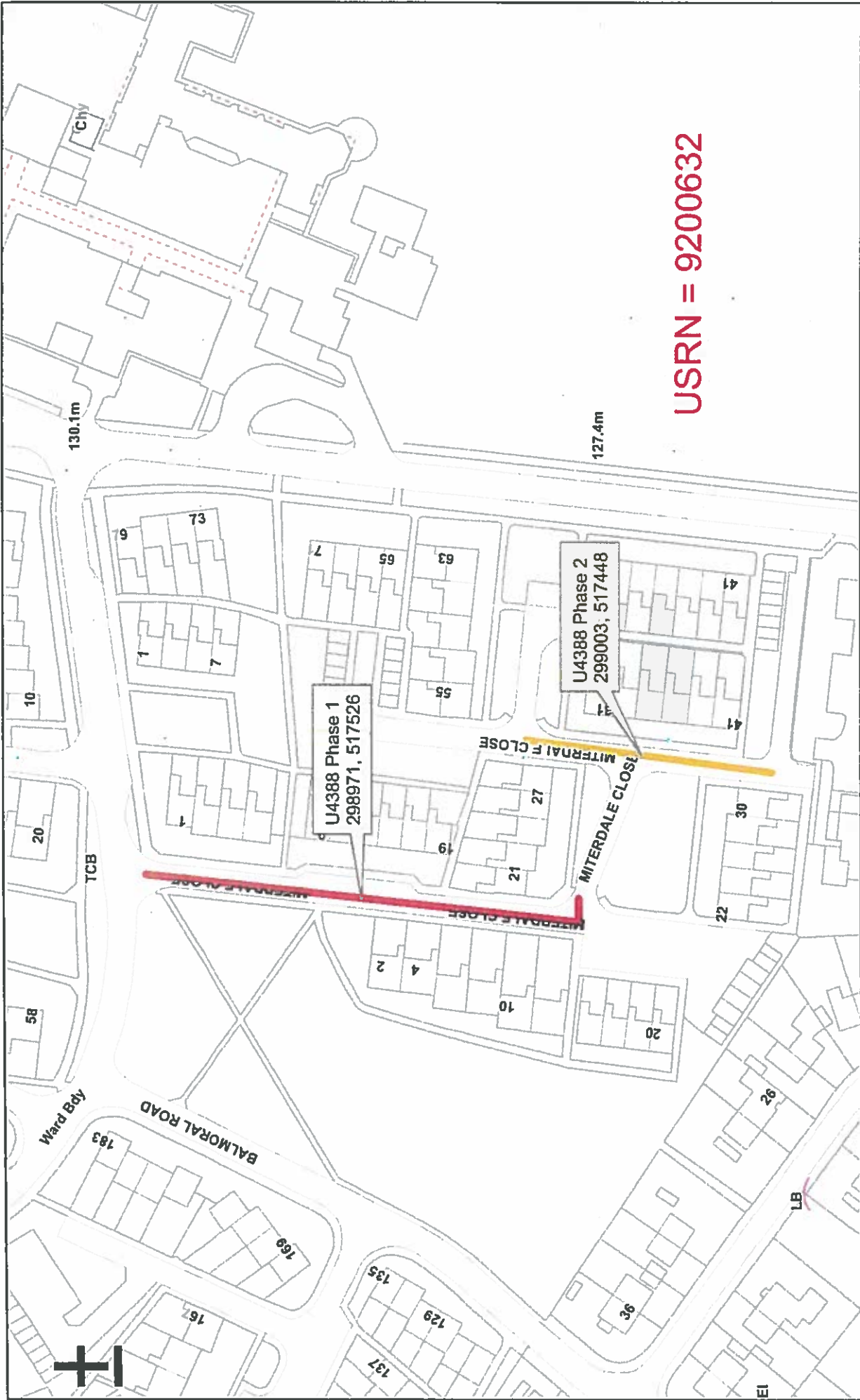
1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.
2. The streets in which these works will take place are: Miterdale Close, Whitehaven, Cumbria.
3. Work is expected to affect the Footway.
4. Work is expected to commence on: 20/6/2018 work should begin within one month of this date.

6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 3 years from completion of the works described in paragraph 5 without the consent of the said highway authority, which is not to be unreasonably withheld.
