NOTICE OF SUBSTANTIAL ROAD WORKS FOR ROAD PURPOSES

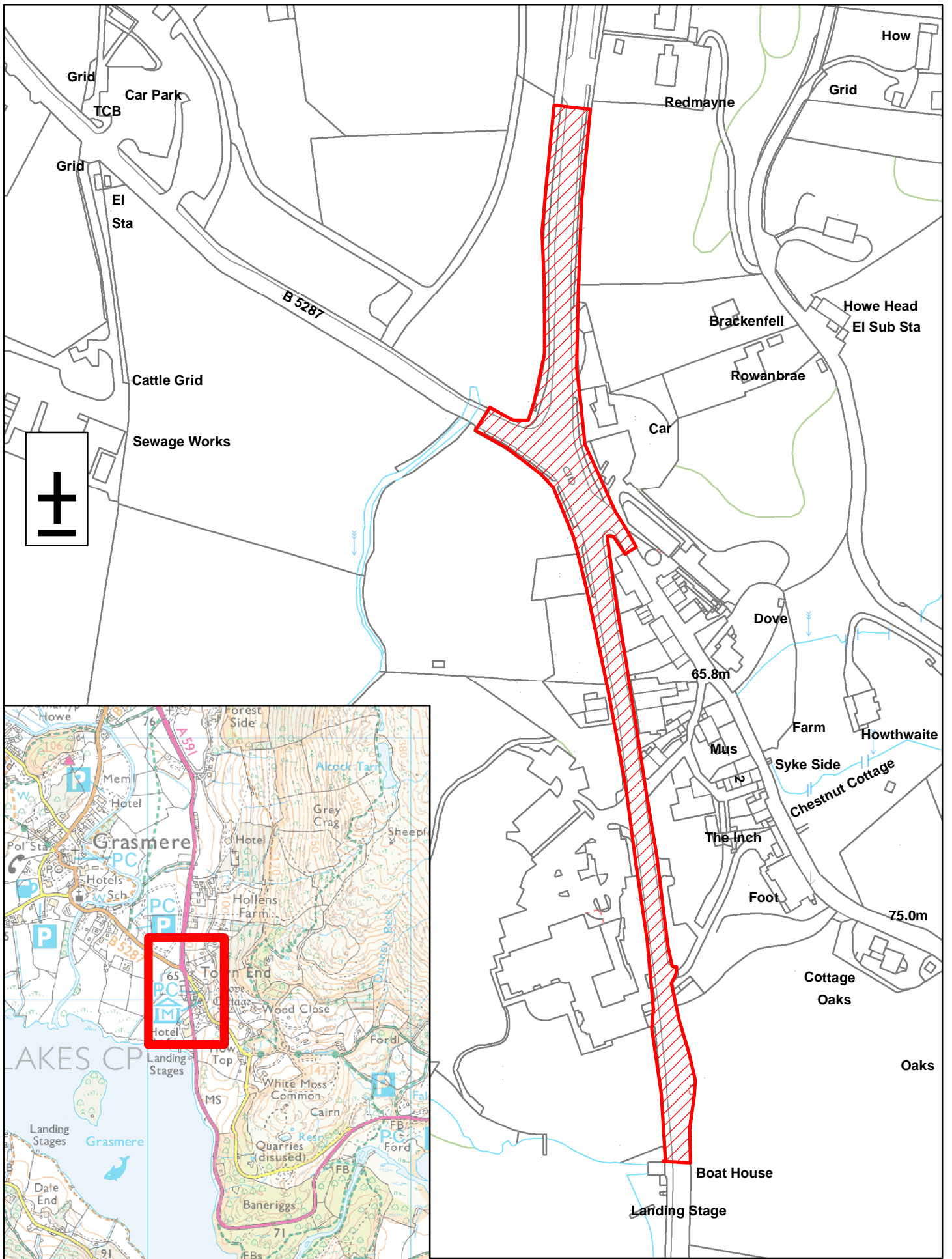
1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.
2. The section of highway in which these works will take place is: B5287 Stock Lane and A591 Lake Terrace, Grasmere.
3. Work is expected to commence on: 8th May 2017.
4. The works notified will include the following:

OS Refs: 334124, 507138 to 334150, 506793

Description of Works –

- Public realm works including earthworks, drainage work, kerbing and edging, street and traffic sign lighting, footway and carriageway paving, wall and gateway features street furniture, landscaping works.
 - Extent of works:
 1. The A591 from a point 134m north east of its junction with the B5287 known as Stock Lane, extending in a south easterly direction for approximately 463m.
 2. The B5287 extending from its junction with the A591 at Town End, extending in a north westerly direction for approximately 25m.
 3. The U5526 from its junction with the A591 at Town End, extending in a south westerly direction for approximately 27m.
5. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 5 years from completion of the works described in paragraph 4 without the consent of the said highway authority, Cumbria Highways, which is not to be unreasonably withheld.
 6. If any statutory undertaker has any planned work for this affected area and wishes to execute it before this restriction comes into effect they should, for the purpose of Section 55, give notice of their proposals within 20 working days of this notice.
