NEW ROADS AND STREET WORKS ACT 1991
SECTION 58
NOTICE OF SUBSTANTIAL ROAD WORKS FOR ROAD PURPOSES

1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.
2. The street in which these works will take place is **C5051 Station Road Broughton in Furness (Grid ref:- 321146 487490) USRN 35901228**
3. Work is expected to affect the carriageway/footway/footpath/verge between: **RESURFACING – Carriageway**
4. Work is expected to commence in: **June 2018**
5. The works notified will include the following:
 - (a) (detail area of work) – **Resurfacing As shown on attached plan**
 - (b) (detail extent of work) – **As shown on attached plan**
6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 3 years from completion of the works described in paragraph 5 without the consent of the said highway authority, which is not to be unreasonably withheld.
7. If any statutory undertake has any planned work for this affected area and wishes to execute it before this restriction comes into effect they should, for the purpose of Section 55, give notice of their proposals within 20 days of this notice.
