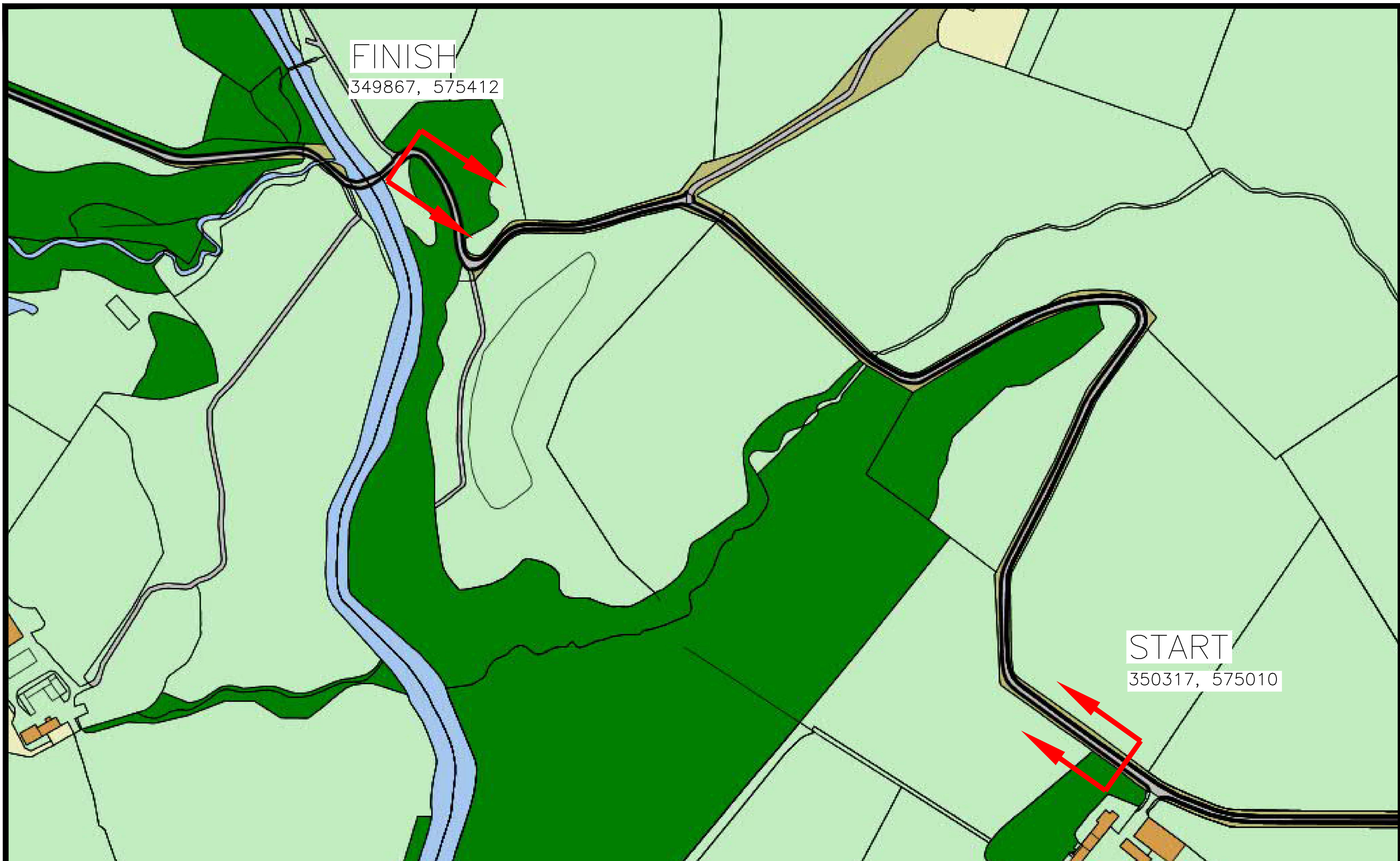
**NEW ROADS AND STREET WORKS ACT 1991**  
**SECTION 58**  
**NOTICE OF SUBSTANTIAL ROAD WORKS FOR ROAD PURPOSES**

1. Three months advance notice is hereby given that Cumbria County Council in its capacity as highway authority intends to carry out substantial works for road purposes.
  
2. The road in which these works will take place is:  
  
U1027, Cumcrook to ford crossing, Roadhead, Cumbria  
  
USRN 5901580  
  
Work is expected to affect the carriageway between:  
  
Cumcrook and the ford crossing  
  
Start NY 350317, 575010 End NY 349867, 575412
  
3. Work is expected to commence on 01/05/2016
  
4. The works notified will include carriageway reconstructing to a depth of 100mm
  
5. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 3 years from completion of the work described in paragraph 5 without the consent of the said highway authority, which is not to be unreasonably withheld.
  
6. If any statutory undertake has any planned work for this affected area and wishes to execute it before this restriction comes into effect they should, for the purpose of Section 55, give notice of their proposals within 20 days of this notice.
