The Indices of Multiple Deprivation (IMD)

The IMD are produced by the Department for Communities & Local Government (DCLG) to consider the unmet needs of small areas, known as Lower Super Output Areas (LSOAs), caused by a lack of resources of across seven domains:

- Income;
- Employment;
- Education Skills and Training;
- Health and Disability;
- Crime;
- Barriers to Housing and Services; and
- Living Environment.

In addition to the above, there are two supplementary indices:

- The Income Deprivation Affecting Children Index (IDACI); and
- The Income Deprivation Affecting Older People Index (IDAOPI).

Deprivation scores for each LSOA across all of the above domains are also combined to create an overall Index of Multiple Deprivation score and rank for each LSOA.

When deprivation scores are combined for all LSOAs in Barrow-in-Furness, the district is classified as the most deprived district in Cumbria for overall deprivation, and falls within the 10% most deprived nationally. It falls within the 10% most deprived nationally in terms of Employment deprivation; Health deprivation & Disability; and Living Environment. Barrow-in-Furness falls within the 20% most deprived nationally in terms of Income deprivation.

The following eleven LSOAs in Barrow-in-Furness rank within the 10% most deprived of areas in England in terms of overall deprivation:



Seven domains: There are 8 LSOAs which rank within the 10% most deprived of areas in England in relation to Income deprivation, these fall within the wards of Central, Hindpool, Barrow Island and Ormsgill. There are 13 LSOAs which rank within the 10% most deprived areas of England in relation to Employment deprivation, these fall within the wards of Central, Hindpool, Barrow Island, Ormsgill, Risedale, Newbarns, and Walney North. There are 10 LSOAs which rank within the 10% most deprived areas of England in relation to Education, Skills & Training deprivation, these fall within the wards of Central, Hindpool, Barrow Island, Ormsgill, and Risedale. There are 24 LSOAs which rank within the 10% most deprived areas of England in relation to Health deprivation & Disability, these fall within the wards of Central, Hindpool, Barrow Island, Ormsgill, Risedale, Newbarns, Walney North, Roosecote, Walney South, Parkside and Hawcoat. There are 8 LSOAs which rank within the 10% most deprived areas of England in relation to Crime deprivation, these fall within the wards of Central, Barrow Island, Hindpool, Risedale and Parkside. There are 20 LSOAs which rank within the 10% most deprived areas of England in relation to Living Environment, these fall within the wards of Barrow Island, Central, Ormsgill, Hindpool, Risedale, Dalton North, Dalton South, Parkside and Walney South.

Supplementary indices: There are 12 LSOAs which rank within the 10% most deprived of areas in England in relation to **Income Deprivation on Affecting Children Index**, these fall within the wards of Hindpool, Ormsgill, Central, Risedale, Barrow Island, and Roosecote. There are 4 LSOAs which rank within the 10% most deprived of areas in England in relation to **Income Deprivation on Affecting Older People Index**, they fall within the wards of Hindpool, Ormsgill, Newbarns and Walney North.




Figure 2: Ward Name and Map ID:

Figure 2 plots each LSOA in the district shaded according to overall deprivation scores; areas shaded in red represent communities that are in the 10% most deprived of areas in England, while areas shaded in dark green represent communities that are in the 10% least deprived of areas in England. Ward boundaries are overlaid onto the LSOA data.
