# School Amalgamation Consultation



Consultation on behalf of the governors of St Mary's Church of England Nursery and Infant School and Windermere Church of England Junior School and the Diocese of Carlisle

### **The Proposals**

The governing bodies of St Mary's Voluntary Aided Church of England Nursery and Infant School ("the Infant School") and Windermere Voluntary Aided Church of England Junior School ("the Junior School") are proposing that:

- the two schools will amalgamate to become a single full-range (3-11) Voluntary Aided Church of England primary school ("the Primary School") from September 2013
- the Published Number (PAN) of the school on entry at 5 will be 60
- the amalgamated school will have no junior PAN
- the new school nursery will cater for up to 104 pupils
- the process for admission of children to both schools for September 2013 is unchanged, and all children allocated places under the current arrangements will automatically have a place in the new school
- admission arrangements for the new school for admission in September 2014 will be the responsibility of the new governing body
- all pupils currently attending the Infant School will automatically have places at the amalgamated Primary School
- all pupils currently attending the Junior School in years 3 to 5 will automatically have places at the amalgamated Primary School
- arrangements for transfer from the nursery to the new school will not change

### It is proposed that:

- a new full primary school will open on 1 September 2013 to include the Nursery, the Infant School and the Junior School
- the Nursery and Infant School and the Junior School will close as a separate schools on 31 August 2013 and become part of the Primary School
- all staff and pupils will become part of the expanded school, and children from both the closing schools will then be on roll at the Primary School

### Published Admission Numbers (PANs) and places from September 2013

These are the Published Admission Numbers (PANs) and places currently at the schools:

Nursery admission will be unchanged in the new school.

These are what the proposed Published Admission Number (PAN) and places available will be under the proposals:

The new school Nursery will cater for up to 104 pupils.

This is a reduction of six in the number of available primary school places in the community for Years 3, 4, 5 and 6. We will discuss this further on in the document.

### Why are we making these proposals?

The Head of Windermere CE Junior School has moved to a new post. This is an ideal time to consider changing the organisation of both schools.

Where the majority of children from an infant school transfer to a single school for their junior (Key Stage 2) education, it is Cumbria County Council policy to consider amalgamating these schools, and the Board of Education of the Diocese of Carlisle supports this policy.

The governing bodies are looking for a provision that best meets the needs of children in the schools and in the area, now and for the future.

Creating a single primary school from the separate infant and junior schools will benefit children by enhancing the provision in the area.

St Mary's CE Nursery and Infant School and Windermere CE Junior School provide a good quality education. However, a full-range primary school has the following advantages:

- a seamless transition from Key Stage 1 (Infants) to Key Stage 2 (Juniors)
- greater opportunities for curriculum continuity and development
- greater opportunities for staff development
- greater flexibility with a combined budget to deploy staff and curriculum resources effectively
- greater opportunities for staff recruitment
- The range of teaching and leadership opportunities in primary schools are likely to attract aspiring head teachers in future

### Demand for school places in the area

The area is currently served by 4 schools for primary age children: St Mary's Church of England Nursery and Infant School, Windermere Church of England Junior School, Goodly Dale Community Primary School and St Cuthbert's Catholic Primary School. On the basis of Published Admission Numbers (PANs) the total number of Reception places in Bowness and Windermere is 86 and the total number of places at the beginning of Key Stage 2 is 92. There is also an independent preparatory school, part of The Windermere School, located in Windermere.

The position for St Mary's CE Nursery and Infant School and Windermere CE Junior School is that there are vacancies in each year group. Pupil numbers in each year group are as follows.

We foresee fluctuating numbers over the next few years as different size year groups pass through the school. The County's projected pupil numbers for the area are, however, forecast to rise. The General Practitioner register indicates that the number of pre-school children living in the area is steadily increasing from 68 Reception age children in September 2010 to 78 children who are expected to attain Reception age in September 2015.

The proposed new school will have a reduced number of Key Stage 2 places (from 66 to 60). This will still leave more than sufficient school places in the area to accommodate the expected levels of demand.

As a larger school, the proposed amalgamated school will be in a stronger position to cope with the expected fluctuations.

### **Amalgamation Process**

When two schools amalgamate there are 3 possible routes:

- close both schools and establish a new primary school
- close the Infant School and expand the Junior School
- close the Junior School and expand the Infant School

### The preferred process

The governors of both schools believe that the formal closure of both existing schools and forming a new full-range primary school best reflects the strengths of the two good schools we have, and will form the most effective basis for combining their qualities in the new school. The proposals are linked and the new school could not happen without agreement to close the schools.

This consultation is being carried out on behalf of both governing bodies and the Diocese of Carlisle. Legally only the Diocese is allowed to propose creating a new church school, while it is the responsibility of the governing bodies to close the existing schools. The Diocesan Board of Education has passed a resolution supporting in principle the amalgamation subject to the outcome of the consultation process.

### What happens next?

We are going to hold a public meeting at Windermere Church of England Junior School, Princes Road, Windermere, LA23 2DD on Wednesday 17<sup>th</sup> October, 2012 at 7.00 p.m. Please come and share your views. The Consultation lasts until **Friday 9<sup>th</sup> November, 2012**.

We want to emphasise that **NO FINAL DECISION WILL BE TAKEN ON AN AMALGAMATION OF THE TWO SCHOOLS** until your views are known. The response form asks whether or not you think an amalgamation is a good idea.

We will analyse the responses and then a report goes to each governing body and to the Diocesan Board of Education. The governing bodies and the Diocesan Board of Education, will consider whether to take the amalgamation forward in light of the responses to the consultation. If they decide to go ahead linked Statutory Notices will be published. There will be a 6 week representation period to comment on these Notices.

The responses to the Statutory Notices received during the representation period are analysed and a report is then sent to the County Council's Cabinet which makes the final decision regarding closure of the schools and the opening of the new school.

If the proposals are approved, a temporary governing body will be set up for the new school which will be responsible for the appointment of staff and the other arrangements that are required. This will be made up from governors from both schools. The existing governing bodies will manage the existing schools until their closure.

### Where can I find out more?

This consultation document is available on the schools' web sites and the diocesan web site. There will be an opportunity to ask questions and make your views known at the public consultation meeting.
